Debt Pre-Levy Resolution & Escrow Agent Agreement Amendment

Thomsen moved to approve the resolution authorizing the redemption of General Obligation School Bonds, Series 2017, dated Dec 1, 2017, approving the first amendment to Escrow Agent Agreement, and levying a tax for fiscal year 2025 for the redemption of General Obligation School Bonds, Series 2017, dated Dec 1, 2017. Taylor seconded. Motion carried 3-0.

Policy Review

The board continued their annual review of policy. Thomsen moved for the first and final reading of policies 503.6-504.2 and 504.4. Taylor seconded. Motion carried 3-0.
